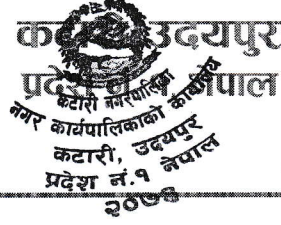

3. Sealed Bids must be submitted to **Katari Municipality Office, Katari, Udaypur**. On or before 12:00 PM on 2074-01-22. Documents received after this deadline shall not be accepted.
4. Bids shall be opened in the presence of Bidders' representatives, who choose to attend at the address above at 2:00 PM on 2074-01-22. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security, amounting to amount mentioned above i.e. 2.5% of quoted amount.
5. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
6. Bids should comply in all respects with the Instruction to Bidder included in the Bid Document. Non compliance with this instruction shall result in disqualification.
