Invitation for Bids for the Construction of Katari Municipality Administrative Building

1. Katari Municipality, Office of Municipal Executive invites electronic bids from eligible bidders for the Construction of Katari Municipality Administrative Building under National Competitive Bidding - Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs 54,500,000.00 [NRs Fifty Four Millions and Five Hundred Thousands only]**

Minimum Work experience of similar size and nature: **1 number of project with minimum value of NRs 33,000,000.00 [NRs Thirty Three Millions only].**

2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

A complete set of Bidding Documents may be purchased from **Katari Municipality, Office of Municipal Executive, Province 1** by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of **Rs 5,000** till **16th December 2022 during office hours**. Or

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below .

Pre-bid meeting shall be held at **Katari Municipality, Office of Municipal Executive** at **1:00 PM on 1st December, 2022**.

5. Electronic bids must be submitted to the office through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 PM on 18th December, 2022**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **1:00 PM on 18th December, 2022** at **Katari Municipality, Office of Municipal Executive**. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **1,400,000.00 [Fourteen Lakhs only]** which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
