- 2. Katari Municipality Office invites a electronic bids from eligible bidders for the construction of Chayga Ring Road Black Top Road nirman under National Competitive Bidding procedures. Only eligible bidders with the following key eligibility criteria should participate in this bidding i.e. Form, Organization or Company Registration Certificate, Business registration License, VAT registration certificate, TAX Clearances Certificate up to 077/078 and Declaration Letter.

Bidders, submitting their bid electronically, should deposit the cost (as specified above) of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. - 5. Electronic bids must be submitted to the office of Katari Municipality Office through PPMO website <a href="www.bolpatra.gov.np/egp/">www.bolpatra.gov.np/egp/</a> on or before 12:00 on 2nd Baishakh, 2079. Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00, 31th days. at the office of Katari Municipality. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security amounting to a minimum Mentioned below which shall be valid for 30 days beyond the validity period of the bid (i.e. 120 days).
- 7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
